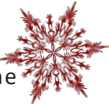


# Winter 2017 Tenant Newsletter

## MONTHLY SALE REPORTS

## PROPERTY MAINTENANCE

Your HVAC (Heating, Ventilation and Air Conditioning) systems air filters should be changed not when they're dirty but on frequently planned intervals. During peak seasons (summer and winter) your system is working much harder and therefore your air filter will need to be checked and replaced more often. Per your lease tenants are required to change their filters. We will be starting a new maintenance check up routine and will send out further information soon. Please be prepared!



## REMINDER

Please remember that your rent is due at the beginning of each month. Tenant's rent becomes late after the 10th of the month. If your rent is late, we will have to issue you a \$250.00 late fee!
